

LAKE GEORGE PARK COMMISSION REGULATIONS

- All vessels 18 feet or longer, or any vessel mechanically propelled by a motor 10 h.p. or greater, must register with the Lake George Park Commission and display a registration decal.
- All trailered boats are subject to inspection and possible mandatory boat washing at designated location, the closest is Rogers Rock Campground.
- The closest boat launch is located at The Hague Beach.

SILVER BAY BOAT SLIP GUIDELINES AND AGREEMENT

- Dock space will be available from May 1 through October 31.
- All members of an immediate family who expect to use their boat must be members.
- The majority of our slips are limited to boats that are a maximum of 21 feet long with an 8 foot beam. We have limited space available for boats over 21 feet please contact us for availability.
- Slips are assigned in the following priority:
 1. On-Campus Guests and Program Pass Guests
 2. Basic Guest Pass and Non-Guests
 3. Staff
- Slip reservations will be assigned on a rolling basis, only after all fees have been paid.
- The Association assumes no responsibility/liability for boats docked, moored, or parked on the campus. Boats are assigned dock space or moorings, but may be moved for reasons of safety or convenience by the Boathouse staff.
- Reservations are made on a first come, first served basis. If your boat has been docked here before and you would like the same slip, please note the slip number and every effort will be made to assign it to you contingent upon the beam of your boat.
- Please Note: Boathouse fees must be paid in full when the reservation is submitted. Reservations will not be held unless the appropriate fee is paid in advance.
